

Face Painting T & C's

Colour Me Face Painting & Body Art

FEES/DEPOSITS/PAYMENTS

A non-refundable \$50 deposit is required to secure your date. Balance is payable 2 days prior to the day of your event or unless stated otherwise.

If payment is not received your booking may be forfeited and the requested date and time will be made available to other prospective clients.

Travel fees apply and will be quoted when booking.

Early bump in times incur extra fees and will be quoted when booking.

Parking space must be allocated, or any parking fees will be charged to the client.

Additional luggage fee may be applied if travelling far from the vehicle, stairs, etc.

AGREEMENT

The event organizer agrees to provide a contact person before and during the event. It is the responsibility of the event organizer to locate the artist under protected cover (shade, verandah, gazebo) if the event is outside. Failure to do so will give the artist the right to withdraw their services. Gazebo hire is available.

The artist needs to be positioned on flat ground where there are no hills or holes and free from loose materials such as sand, rocks, etc

The artist requires a minimum area of 1.5m x 1.5m to work in.

The event organizer agrees to ensure the guests are always behaving well around the artist. Children must have parental supervision at all times.

HEALTH & SAFETY

The artist will NOT paint dirty or sticky faces or anyone who looks sick. This includes, but is not limited to, allergies, broken skin, coughing, sneezing, runny nose, rashes, red eyes etc.

Face Painting is not recommended for children under the age of 3 and not covered by insurance.

The event organizer is required to let the artist know if anyone has sensitivities or allergies. All products used are water-based, hypoallergenic, non-toxic and comply with US FDA and EU regulations. However, please note that all cosmetics can on rare occasions cause allergic reactions. Colour Me accepts no liability for this.

If the person to be painted has not been painted before or has sensitive skin, it is possible that face painting may cause irritation. Please ask for a patch test. If there is no reaction after 15 minutes, the person may be painted.

PRIVACY

Colour Me may take photos for private or public use. Consent will be gained from parents or individuals before using photos publicly for advertising or other purposes. Colour Me holds personal information relating to event bookings. Colour Me will take reasonable steps to protect all personal information from loss or disclosure. Colour Me will not be liable for any loss, damage or theft as a result of your use of this website. It shall be your own responsibility to ensure that any products, services or information available through this website meet your specific, personal requirements.

CANCELLATION

Your \$50 deposit is non-refundable.

In the case where the weather is not ideal for face painting, (wind, rain, heat, cold) Colour Me will come to an arrangement with the customer to reduce the impact of the weather. If it is not possible to avoid the weather, Colour Me reserves the right to cancel the booking on the day and will provide a full refund.
